TERMS OF USE

AGREEMENT TO TERMS

These Terms of Use constitute a legally binding agreement made between you, whether personally or on behalf of an entity ("you") and LerBee, Inc., doing business as LerBee (the "Company", "LerBee", "we", "us", or "our"), , including its affiliated companies and the shareholders, directors, officers, employees, consultants, contractors, subcontractors, agents, advisors, assignees and successors, concerning your access to and use of the https://lerbee.com website as well as any other media form, media channel, mobile website or mobile application related, linked, or otherwise connected thereto (collectively, the "Site"). We are registered in Delaware, United States and have our registered office at 919 North Market Street, Suite 950, Wilmington, DE 19801. The Site provides an online platform through which personal shopper services are provided in order to facilitate remote selection and purchase of goods (the "Shopper Services"). In order to help make the Site a secure environment for the purchase and sale of Shopper Services, all users are required to accept and comply with these Terms of Use. Supplemental terms and conditions or documents that may be posted on the Site from time to time are hereby expressly incorporated herein by reference. We will alert you about any changes by updating the "Last updated" date of these Terms of Use, and you waive any right to receive specific notice of each such change.
